01	Grievance submitted by M/s Ghani Chemical Industries Ltd Diary No. 8525/LGH dated 17-05-2022 Ghani Chemical Industries has grievance on the participation of Multan Chemical Industries Limited for the supply of Medical Liquid Oxygen Firm states that; 1. They do not have any market experience for supplying Medical Liquid Oxygen in public sector for the similar size hospital as FMU/Allied/DHQ Hospitals. 2. They do not have Backup plant which is a must requirement to meet the hospital requirements under emergency and in disaster situation like Covid-19 3. Their plant was started in Jan 2021 and its reliability and continuous operation is still question mark especially during COVID waves. 4. In case of plant break down they would not be able to ensure the continuous supply of Medical Liquid oxygen as per hospital requirement. 5 Multan Chemicals Limited has no backup oxygen plant storage to ensure continuous and uninterrupted supply of Liquid Medical Oxygen to hospitals in the event of plant storage failure or emergency. They only have a single storage tank on perlite technology without vacuum, which is an obsolete technology and not a single established and proven Liquid Medical Oxygen supplier is utilizing in Pakistan: As a matter of fact, Ghani Chemical Industries Scrapped its Perlite Base Liquid Oxygen Storage Tanks due to their reliability, risk and safety factor. 6. Multan Chemicals Limited has no third party certificate/analysis report which validates Oxygen produced by them is in line with EU/US Pharmacopeia Standards and is of Medical Grade fit for Life Saving purpose.	As per Result of TEC, Multan Chemical Industries is already non responsive for the under grievance item for T.E No.12 due to Short experience of Liquid oxygen.	Representative of M/S Ghan Chemical Industries limited attended the meeting and described their grievance against M/S Multan Chemicals The committee evaluated it to conclude the matter. There are many short comings found in terms of experience and expertise in dealing with liquid oxygen for the other company though it is already declared NON Responsive.  After due deliberation and detail discussion, it is unanimously decided to UPHOLD decision of T.E.C. Hence outcome of result will be remained same.
