- Sealed bids are required to be brought in person by the authorized representative of the interested Bidders in the committee Room Lahore General Hospital, Lahore, which will be opened in the presence of the authorized representatives of the Bidders.
- Procurement shall be governed by the Punjab Procurement Rules 2014.
- The Bidders are required to furnish bid security, which should be 2% of the estimated cost of quotec product as per tender list in shape of CDR/ Bank Guarantee only (issued by a scheduled bank operating in Pakistan), in the name of Medical Superintendent Lahore General Hospital, Lahore along with the tender.
- The 2 % bid security must be attached with financial bid and defaced copy attached with technica bid.
